### WE Performance Record

WE United “r” Judge Licensure requires documentation that the candidate has earned a WE United Bronze or higher Lifetime Rider Medal. To earn a Bronze Rider Medal, a member must have three Dressage and three EOH scores at the Novice level of 62% or higher from at least two different WE United “r,” “R,” or “S” judges, and at least one Dressage and one EOH score at the Novice level of 65% or higher. Beginning in the 2019 competition year, a minimum of two of the four Dressage and EOH scores (each) must be earned while competing in Novice B. Scores for all of the above are only eligible if the rider successfully completed all trials in the competition in which the score was earned.

WE United “r” Judge Licensure requires documentation of havng judged a minimum of 50 rides at schooling shows within the two-year period immediately prior to date of application. Rides that were co-judged with “R” or “S” judges will count toward fulfilling this requirement.
